I agree to the following terms and conditions for allotment of plot :

1. The offer is strictly limited to individuals of Brahmin community alone. The acceptance of Membership is at sole discretion of the management.
2. The allotment of plots to individual members shall be carried out by lottery system and the management decision shall be final. Although requests for group/adjoining plots allotment shall be accommodated to the extent possible, plots once allotted shall not be altered.
3. Every owner of plot in Shankara Agraharam shall join, observe and perform all the rules and regulations which the Owners Welfare Association may adopt from time to time.
4. The total amount paid includes cost of plot including all development charges, Corpus Fund of Owners Welfare Association and Donation to the Trust.
5. After intimation of the allotment of plot, Registration Expenses & other incidental expenses shall be borne by the applicant.
6. The allotments are not to be transferred/ assigned before registrations are complete in the applicants name.
7. The applicant is at full liberty to resell, gift, will or otherwise dispose off the property, after the registration of plot is carried out in applicants favor.
8. Balance land after allotment of plots to individual applicants is to be used for the intended activities of the Trust for which the applicant shall have no objections what so ever.
